Dear Parents and Students,

As you aware that to eliminate the scourge of ragging from the Higher Education Institutions in the country, the AICTE (All India Council for Technical Education) has framed a regulation – AICTE Regulation on **Prevention and prohibition of Ragging in technical Institutions, Universities including Deemed to be Universities imparting technical education.**

This regulation is also available on the University's website – www.aedics.ac.in. Under the provisions of the said Regulation ragging has inter-alia been defined as any conduct by any student / students whether by words spoken or written or by an act which has an effect of teasing treating or handling with rudeness a fresher or any other student or indulging in rowdy or indisciplinary activities which causes or is likely to cause annoyance, hardship or psychological harm or creates fear or apprehension thereof in any fresher or any other student or forcing a student to do an act which has the effect of causing or generating a sense of shame or torment or embarrassment so as to affect the physique or psyche of a fresher or any other student, showing of power, authority or superiority by a student to any fresher or any other student. The above said AICTE regulation also provides for punishment to the student found guilty of ragging. These punishments include suspension from attending classes, withholding / withdrawing scholarship, debarring from appearing in the test / examination, withholding results, suspension / debarring from hostel, cancellation of admission, rustication from the institution for certain period and expulsion from the institution.

As per the procedure described by the AICTE, Parents and Students will have to submit the affidavit for "**Measures for prevention of ragging**". The copy of affidavit for Parents and Students is attached with this letter.


Procedure of affidavit for Parents and Students is as follows.

- 1) Affidavit on Rs. 20/- on Non-judicial stamp paper OR duly franked by designated bank.
- 2) Each Affidavit must be notarized by legal notary officer.

Signed affidavit of Parents and Students must be returned on or before 7th August, 2010 to the office.

I hope you will extend your fullest co-operation in anti ragging drive of AICTE..
